To promote the communication and cooperation of energy-saving and environmental protection equipments and low carbon products, Shaanxi Provincial Environmental Protection Department, Shaanxi Provincial Development and Reform Commission, Shaanxi Provincial Housing and Urban-Rural Construction Department, Shaanxi Provincial Commerce Department, Shaanxi Provincial Science and Technology Department, Shaanxi Provincial Exhibition Center will jointly hold "2010 China (Xi'an) International Exhibition on Energy-Saving and Environmental Protection Equipments and Low Carbon Products" from 23th to 25th October 2010 at Xi'an Qujiang International Conference and Exhibition Center. The exhibition is with the theme of "promoting green economy, advocating low-carbon living", and with the goals of thoroughly applying the Scientific Outlook on Development and the outline of China's the Twelfth Five-year Plan, developing cyclic economy, strengthening environmental protection, promoting the coordinative development of the economy and environment.

The indoor exhibition area is divided into 500 standard booths, the outdoor exhibition area is 3,000 m².

Exhibition Scope:

◆ Environmental protection technologies, equipments, products

- Technologies and equipments for air, water, noise and vibration, environmental monitoring, and vehicle exhaust pollution control.



- Urban greening and environmental improvement, sanitation products and special vehicles, municipal solid waste treatment facilities.
- Technologies and equipments for solid waste landfill, incineration, biological and chemical treatment and utilization, and also kitchen waste recycling.
- Technologies and equipments for medical waste, industrial waste, hazardous and toxic waste treatment.

◆ **Environmental protection planning, energy-saving and environmental protection industry development planning**

- Achievements display of environmental protection planning in provinces and urban areas, national cyclic economy demonstration areas, development zones, industrial parks, demonstration projects and enterprises.
- Achievements display of energy-saving and environmental protection industry development planning and key industry projects.

◆ **Industrial energy-saving technologies and products**

- Energy-saving achievements of key industries, key enterprises, especially in coal, electricity, petroleum and chemical industries, etc.
- Energy-saving projects of urban water supply, gas supply, heating, and so on.
- Technologies and products in motor system, power equipment, variable velocity variable frequency technology, by-product heat and pressure utilization, energy-saving of coal-fired industry furnace, steam recovery, condensate recovery, regenerative combustion technology, ecological construction of development zones, industrial waste recycling, industrial water recycling.
- Hybrid electric vehicles, hydraulic hybrid vehicles, new energy vehicles, electric vehicles, energy-saving traffic signal system, etc.

◆ **New energy technologies, equipments and products**

- Display of new energy base.
- Technologies and products of solar photovoltaic technology, solar power generation, photothermal conversion, photoelectrical conversion, solar energy storage, solar energy utilization, etc.
- Technologies and products of wind power generation, waste power generation, biomass utilization, biogas utilization.
- Technologies and products of geothermal energy, ground source heat pump system, clean reformation of coal.

◆ **Green home and low-carbon buildings**

- Display of sustainable and low-carbon buildings.
- Display of green home, such as wooden floors, ceramics, sanitary utensils, hardwares, cabinets, furnitures, home furnishings, etc.



- Energy-saving walls, doors and windows, energy saving construction, decorating materials, building intelligent control systems, building energy-saving technologies, energy-saving heating and cooling systems technologies and measurement technologies.

◆ **Energy-saving life and environmental technologies and products**

- Appliance stores, energy-saving air-conditioners, lamps, household appliances, etc.
- Household water-saving equipments, pumps, valves, sanitary ware products, gas cookers and coal cookers, etc.
- Household purifiers, such as air purifiers, water purifiers, negative ion generators, etc.
- Household cleaning products, such as weeding equipments, waste storage equipments, vacuum cleaners, etc.

Exhibition Activities:

- ◆ **Holding forums on energy saving and emission reduction, exploitation of energy sources and comprehensive utilization of resources.**
- ◆ **Promoting energy-saving and environmental technologies and products, organizing purchasing and procurement.**

Exhibitors should promise to follow relevant terms set forth by the Organization Committee: do not show infringing and counterfeit goods, once discovered, exhibitors will be disqualified and punished; do not exhibit at aisle, emergency exit or fire control facility area; do not underlet booth; do not withdraw before the exhibition.</p> <p>2. After receiving the contract, the Organization Committee will stamp the official seal within three days and fax or mail it to the exhibitors. The exhibitors shall remit all charges of exhibition to the designated account within seven days after the contract. The Organization Committee reserves the right for final decision in adjusting booths.</p> <p>3. The booth no. is confirmed after the contract and payment. If the Organization Committee has to adjust the position of some booths, they should fill in application form to ask for exhibitor's advice. After confirmation by exhibitors, the booth position will be adjusted.</p> <p>4. The contract comes into effect from the day of contract to Oct 25, 2010. Both parties shall fulfil their respective contract obligation. Either party shall not terminate the contract unless force majeure.</p> <p>5. The agreement is in two copies of the same form, each party holds one. (The fax document with both parties's signs and stamps is equally effective)</p> <p>6. After the contract, Exhibitors will fax it back to the Exhibition Department of 2010 China (Xi'an) International Exhibition on Energy-Saving and Environmental Protection Equipments and Low Carbon Products to handle the relevant procedures.</p>
